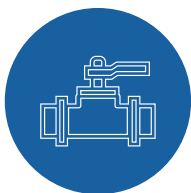




Inspection for industrial goods

Industrial Services

Ensure that industrial components and equipment meet specified standards and regulatory demands.



SPEX's inspection services for industry goods cover every step from raw material, manufacturing process, final inspection, and loading supervision, adding value and reliability to products, projects, and processes.

Testing

SPEX Testing Service verifies the product conformance to design, properties, performance, reliability, and life-cycle. We test, assess, and certify materials and semi-finished materials (plates, tubes, forgings, cast iron/steel, and other metals).

- Witness hydrostatics, pneumatic or any other form of pressure/leak test.
- Witness test for runner assembly.
- Witness test for distributor assembly.
- Witness electrical test and FAT as required by ITP.
- Laboratory test witness.

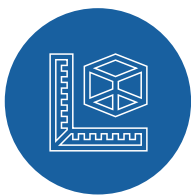

Inspection for consumer goods

Inspection and Site Supervision

Ensure that products, components, and materials meet specified requirements and regulatory demands.



SPEX Inspection Services cover every aspect of manufacturing and distribution operations – including inspections for pre-production, in-production & pre-shipment, and loading supervision – To ensure compliance with local and industry

requirements and customized specifications.

SPEX’s inspection services ensure:

- The quantity produced matches with the quantity ordered.
- The visual appearance matches with the product ordered.
- The product specifications comply with the order.
- The packaging, labeling, instructions, and markings comply with mandatory standards.

SPEX’s inspection services for quality can either check the first finished products getting out of the line or come in at a later stage and select samples from a pool of finished goods.

Our inspections are performed according to the requirements of ISO/IEC 17020. We issue the report within 24 hours of the service performed.

We provide four main services to check on the quality of the supplier’s products:

Pre-Production Inspection (PPI)

For timely corrections of any non-conformities detected.

During Production Inspection (DPI)

For evaluation of average product quality during manufacturing.

Pre-Shipment Inspection (PSI)

An important quality control method for checking the quality of goods.

Container Loading Supervision (LS)

To ensure that products are loaded and secured correctly.



On-site inspection brings a clear evaluation to determine the suitability, quality, reliability, and compliance with the customer’s requirements.



Supplier Audits

Have the international supply chain under control.



Ensure that suppliers operate in accordance with the required competence and capacity for expected production.

SPEX Supplier Audit service monitor the integrity of the supply chain and ensure that systems, management and operation procedures meet expected standards. It ensures that the factory choices meet the social compliances and quality requirements. The service can also be used for periodic supplier evaluations.

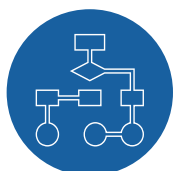

 - Product compliance and tests reports.
 - QMS Certificates and on-site inspections.
 - CSR and social compliance.
2. Search conducting, through dedicated professionals, using the extensive SPEX business network.
3. Total cost analyses (how much does it cost to provide those goods or services?).
4. Identification of suitable suppliers.
5. Development of a sourcing strategy (where to purchase, considering demand and supply situations, while minimizing risk and costs).
6. Negotiation with suppliers (products, service levels, prices, geographical coverage, payment terms etc).
7. Implementation of new supply structure.
8. Track results and restart assessment (continuous cycle, as necessary).

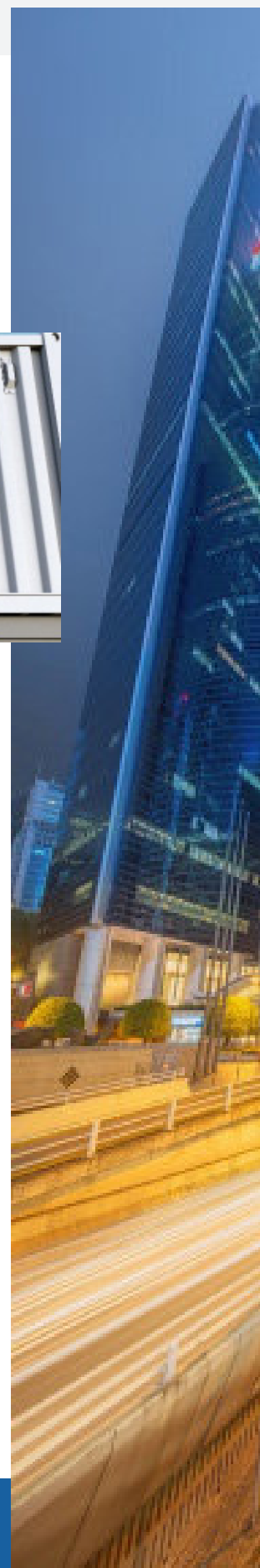
